1. Call to Order and Opening Remarks

Mayor Schaefer welcomed everyone to the meeting.

Councillor Smith provided a welcome back to all, and formally wished Council colleagues, staff, volunteers, residents and ratepayers good wishes for the New Year.

Councillor Smith acknowledged that this is the first meeting in 2025, and just past the halfway mark in the Council term. Councillor Smith provided a summary of the things that Council has achieved since 2022, including the new Administration Building. Councillor Smith noted that the new Administration Building was designed and built without any new taxation levied on ratepayers, debt or debentures. He credited Council's from the past and present, and the Treasury Department's work towards low levels of financial risk as reflected and measured in the annual FIR to the Province. Also noted is that this is the Township's 5th consecutive year running a surplus and running in the black. Councillor Smith noted that the Township is on track to be debt free by 2028.

Councillor Smith also recognized the Township's first ever Strategic Plan, Recreation Master Plan – RAC Committee formation, Tavistock Spray Pad, Commemorative Tree and Bench Program, Flag Pole Program, EZTransit, and the Secondary Plan development.

Mayor Schaefer recognized that January 1st, 2025 marked the 50th anniversary of the merger of East Zorra, and Tavistock. This year also marks the 150th anniversary of County of Oxford.
