Dear Lindsey Mansbridge:

The Upper Thames River Conservation Authority (UTRCA) hosted its Annual General Meeting on February 25, 2025. As part of this meeting the Board of Directors approved the 2025 Budget and apportionment methods. The budget includes revenue originating from municipal levy as authorized by the *Budget and Apportionment Regulation (O.Reg. 402/22)* under the *Conservation Authorities Act*. This notice and invoice are being provided to the Clerk of each member municipality and stipulate the amounts owing for 2025 along with the basis for apportionment.

Municipal contributions for 2025 have been established in accordance with the apportionment methods for Programs and Services as follows:

General Distribution:

That each participating municipality's share of the 2025 Total General Levy Distribution be calculated using "Modified Current Value Assessment" for payment of Category 1 operating and capital expenses presented in the 2025 Approved Budget.

Benefit-Based Apportionment:

Each participating municipality's share of the 2025 "Benefit-Based Apportionment" method be applied for use with respect to operating and capital costs for Dams and Water Control Structures as identified in the 2025 Approved Budget.

Non-Mandatory / Cost Apportionment:

Category 3 programs and services also apply the "Modified Current Value Assessment" (MVCA) method for apportioning costs in agreements with municipalities. Please update UTRCA's Cost Apportionment Agreement Schedule B to reflect the 2025 amounts as attached.

The UTRCA's Board of Directors approved the budgets for 2025 in two parts:

- 1) A projected operating surplus of \$520,876 from \$27,553,066 in operating expenses, requiring \$8,197,570 of participating member levy, and requiring \$626,156 in cost apportioning agreements among members, and
- 2) A projected capital deficit of \$2,338,219 from \$15,483,600 in capital expenditures, requiring \$6,535,881 of participating member levy.

This letter and attachments have been provided for your reference. As well, a copy of the <u>2025 Approved Budget</u> is posted on the Governance page of the UTRCA's website, as required by the *Budget and Apportionment Regulation (O.Reg. 402/22)* under the *Conservation Authorities Act*.
