
Section 7(4) of the Ontario Building Code Act requires that an annual report be prepared and presented to Council on building permit fees collected and the cost to run the department.

The total fees collected in **2024** were **\$336,168.70**. The total number of permits issued was **195**, with an estimated construction value of **\$54,790,338.38**.

As outlined in this report, the Township has recovered approximately **71%** of the expenses to operate the building department in 2024. As required by Section 7(2) of the Ontario Building Code, the Building Department's fees have NOT exceeded the anticipated reasonable cost of administration and enforcement of the Ontario Building Code Act. No transfer is required. The reserve fund is still existent, and the fund is to only be used as part of the enforcement of the Building Code Act.
